

## Director of Finance - Health and Social Services Group - Welsh Government

He joined the NHS as a National Finance Management Trainee in 1984 and apart from two years in Local Government has spent his entire career in NHS Wales. Alan has been a Finance Director in a number of NHS Trusts in NHS Wales since 1994. In 2003 he took the opportunity offered by the creation of Local Health Boards in Wales to become Chief Executive of Carmarthenshire Local Health Board and remained there until 2008 when he returned to finance as Interim Director of Finance in Gwent NHS Trust. From 2009 he was Director of Finance and Procurement and Deputy Chief Executive of Aneurin Bevan University Health Board and during 2012 Alan covered the post of Director of Finance for the Department of Health and Social care in Welsh Government and in September 2016 Alan took up this post permanently.

## **DR. ANNE DEE**

#### Health Technology Assessment Group Lead and Specialist in Public Health Medicine, Department of Public Health

HTAG is headed up by Dr. Anne Dee, who is qualified as a Consultant in Public Health Medicine. Anne specialises in the area of Health Economics, and has experience of Markov

modelling, cost of illness studies, budget impact analysis as well as acute hospital activity and costing projections. During her career, Anne has worked in emergency medicine, general practice and volunteered in a leprosy hospital in Nepal. She has worked in Public Health Medicine since 2006, and took up a specialist post in Limerick in 2010.

## **DR. THOMAS KELLEY**

He was a civil servant in Northern Ireland for four years and has worked in hospital management, including a period as chairman of the board at Central Middlesex Hospital and is currently on the boards of St. James's Hospital and Trinity Health Ireland. His BA and DPhil are in economics.

#### DR. MÁIRÍN RYAN **Director Health Technology Assessment and Deputy Chief Executive Officer HIQA**

Máirín joined HIQA as Director of Health Technology Assessment (HTA) in September 2007. She was appointed Deputy Chief Executive in September 2014. Prior to this appointment, Máirín was the Chief 1 Pharmacist at the National Centre for Pharmacoeconomics. She is an Assistant Professor in Pharmacoeconomics at Trinity College. She and her team are responsible for conducting assessments of health technologies including drugs, devices, diagnostics and public health programs. In addition, HIQA has recently been selected to provide the evidence synthesis to support the development of National Clinical Guidelines and National Clinical Audit.
